XTC SQUAMISH - WAIVER

AWARENESS AND ASSUMPTION OF RISK

I am aware that triathlons, duathlons and multisport events involve risks including risk of personal injury, death, property damage, expense and related loss, including loss of income. Included in these risks are negligence on the part of Teri Taylor dba Cove Communications (XTC Off-Road Multisport Series), its directors, officers, officials and volunteers, other participants, owners of the facilities where the activities occur (Sea to Sky Park Services Ltd., District of Squamish, Integrate Land Management Bureau, BC Hydro, BC Transmission Corporation), sponsors, its Lifeguards and Triathlon British Columbia (referred to in the rest of this agreement as "Cove Communications AND OTHERS"). I freely accept and fully assume all such risks and the possibility of personal injury, death, property damage, expense and related loss, including loss of income.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of Cove Communications accepting my application to participate in this activity, I agree:

1. To waive any and all claims that I may have in future against Cove Communications AND OTHERS.
2. To release Cove Communications AND OTHERS from any and all liability for any personal injury, death, property damage, expense and related loss, including loss of income that I or my next of kin may suffer as a result of my participation in this activity, due to any cause whatsoever, including negligence, breach of contract or breach of any statutory duty of care.
3. To hold harmless and indemnify Cove Communications AND OTHERS from any and all liability for any damage to property of, or personal injury to, any third party, resulting from my participation in this activity.
4. That this agreement is binding on not only myself but my next of kin, heirs, executors, administrators and assigns.

TRIATHLON BC - WAIVER

RELEASE AND INDEMNITY

PLEASE READ CAREFULLY

I, the applicant, on behalf of myself, members of my family, my heirs, executors, administrators and assigns, hereby forever release, discharge and hold harmless Triathlon BC (Triathlon BC) representatives and agents for any injury, loss or damage to my person or property howsoever caused, arising out of or in connection with my taking part in Triathlon BC organized events and activities and notwithstanding that the same may have been contributed to or occasioned by the negligence of the Triathlon BC representatives or agents. I acknowledge that I am responsible for the roadworthiness and correct operation of my bicycle. I realize that I may be subject to unannounced drug testing as provided for by Triathlon Canada's agreement with the Canadian Centre for Ethics in Sport.

I HAVE READ THIS AGREEMENT (The XTC Squamish and the Triathlon BC Waiver) AND UNDERSTAND IT. I AM AWARE THAT BY SIGNING THIS DOCUMENT I AM WAIVING CERTAIN RIGHTS WHICH I OR MY NEXT OF KIN, HEIRS, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST COVE COMMUNICATIONS AND OTHERS.
